**STANDING RULES OF  
WICHITA AREA WOMEN'S GOLF ASSOCIATION  
OF WICHITA, KANSAS**

**ARTICLE 1  
Standing Rules**

**Section 1.** Standing Rules, with the exception of those dealing with Team Play, may be adopted or amended at any regular meeting of the Board of Directors by a majority vote, provided that the proposed Standing Rule or amendment has been communicated to all Member-Clubs at least fourteen (14) days prior to the meeting.

**Section 2.** Team Play Standing Rules may be adopted or amended by the Member-Club Team Play Captains at any regular or called Team Play Captains meeting by a majority vote of those present. 18-hole Team Captains shall vote on specific 18-hole rules. 9-hole Team Captains shall vote on specific 9-hole rules. All other rules shall be voted on by 18- and 9-hole Team Captains.

**Section 3.** Standing Rules shall be reviewed every three (3) years.

## ARTICLE II

### Eligibility

#### Section 1. General

- a. Ladies may be eligible to play in WAWGA tournaments in the following ways:
  1. Be a member in good standing of a WAWGA member club
  2. Be a Single member. This is an individual who resides in the state of Kansas and has a GHIN handicap. These ladies shall submit a Single Membership form and an annual fee as determined by the WAWGA Executive Board. Membership will be good for one (1) calendar year. As of 2022, this fee is \$20.00. These individuals will not have delegate representation at WAWGA meetings, nor will they be eligible to play in Team Play or the Orlando tournament.
  3. Individuals may also play in a WAWGA tournament by paying an additional entry fee for a particular event. This fee will be determined by the CTC and the Executive Board each year. As of 2022, the fee is \$5.00 per tournament.
  4. All members of WAWGA clubs, single WAWGA members and ladies who enter by paying an additional fee are eligible to play in all 18 and/or 9-hole events, excluding Team Play or the Orlando
  5. A member of more than one Member-Club shall represent only one club for the season. Once she has represented a Member-Club in a WAWGA event, she shall represent that club for the season. *Exception: If an individual is a member of more than one Member-Club and is the 18-hole Champion at any/all those clubs, she may play only in the Orlando Tournament as the representative of one Member-Club, at her discretion, where she is the 18-hole Champion.*
  6. If a member of a Member-Club drops her membership in that club and is no longer eligible to play at that club, she may represent another club after fulfilling the requirements of **Article II. Eligibility, Section 1. General a.**

#### Section 2. Junior Golfers

- a. A “junior golfer” is an amateur golfer who has not yet reached her 19<sup>th</sup> birthday.
- b. Junior golfers shall:
  - 1) Be eligible to play in only 18-hole events.
  - 2) Be required to have an 18-hole Handicap Index that does not exceed 30.0.
  - 3) Be a member in good standing of a Member-Club or be a member of an established Kansas ladies golf association.
  - 4) Be eligible to compete in only the following events: Wichita Match Play Tournament and Team Play. This is due to the KSHSAA regulations that:
    - a) Forbid receipt of merchandise prizes.
    - b) Forbid aiding other members on a team to receive merchandise or prize money.
    - c) Allow plaques, medals, trophies, ribbons, and certificates as prizes.

**ARTICLE III**  
**Club Rotation Schedule**

**Section 1. Tournament Long Range Schedule** (Appendix A)

- a. Member-Clubs shall be in the following order when making the Long-Range Schedule of tournaments:
  - Willowbend Golf Club
  - Sim Golf Club
  - Reflection Ridge Golf Club
  - MacDonald Golf Course
  - Wichita Country Club
  - Tallgrass Country Club
  - Crestview Country Club
  - Terradyne Golf Course
  - Derby Golf Course
  - Hidden Lakes Golf Course
  - Auburn Hills
  - Rolling Hill Country Club
  - Tex Consolver Golf Course
- b. A change of a Member-Club's name shall not change the position of the order.
- c. When a new club is admitted to the WAWGA, it shall be entered in the order of Member-Clubs where the Executive Board deems the most equitable position. An effort shall be made to have the number of years between hosting of tournaments equal among the Member-Clubs.
- d. The current Tournament Long-Range Schedule shall be attached to the Standing Rules (Appendix A).
- e. If a Member-Club changes division status notification shall be made at the Fall meeting.

**Section 2. Central Tournament Committee (CTC)**

- a. The CTC will be conducting all Tournaments at all site locations.
- b. The Four-Ball Tournament shall be rotated among all WAWGA Member Clubs and all clubs governed by the contract between WAWGA and Wichita Golf. (Appendix A).
- c. The Senior Tournament shall be held at Sim Golf Club each year.

## **ARTICLE IV**

### **Rules and Arbitration**

**Section 1.** All competitions of WAWGA shall be in accordance with the Rules of Golf as adopted by the United States Golf Association (USGA) and such local rules as adopted by the Rules and Arbitration Committee of each tournament.

**Section 2.** The Central Tournament Committee (CTC) will serve as the Rules and Arbitration Committee for all tournaments under the supervision of the Golf Pro at the Member-Club where a tournament is being held.

**Section 3.** All competitions of WAWGA may award prizes, gift certificates or cash awards to players at the discretion of the Central Tournament Committee.

**ARTICLE V**  
**Tournaments – General**

**Section 1.** See Tournament Long-Range Schedule, (Appendix A), for tournament sites.

**Section 2.** All WAWGA tournaments will be planned, conducted, and supervised by the Central Tournament Committee (CTC)

a. Duties of Central Tournament Committee

- 1) Set dates for all tournaments in coordination with club pros.
- 2) Determine entry fees which include green fees, prizes, luncheon, and other tournament expenses. Green fees at Wichita public courses will be determined by the contract negotiated between Wichita Golf and WAWGA. All other green fees will be negotiated with the course.
- 3) Create information flyer and/or theme for the tournament, as well as entry form. Communications member of CTC will send to all Member-Club presidents and to WAWGA Website Coordinator.
- 4) Set deadline for receipt of entries.
- 5) Obtain the World Handicap System (WHS) Handicap Index for each contestant from GHIN.com.
- 6) Receive entries and pay all expenses of the tournament not paid by WAWGA.
- 7) Send email confirmations to all entrants on receipt of their mail in entry form. Online entries create their own receipt.
- 8) Provide publicity updates.
- 9) Purchase prizes and/or prepare given certificates and awards for winners.
- 10) Given financial statement and receipts to the WAWGA Treasurer along with any surplus funds after all expenses of the tournament have been paid.

b. Duties of host course

- 1) Assist with communications between CTC and Club Golf Pro.
- 2) Provide volunteers for transporting bags, spotters, registration, etc. as needed.

**Section 3.** WAWGA will pay \$250 per day of play to assist with tournament expenses. This can be used however the CTC sees fit, such as for:

- a. refreshments at the tournaments
- b. trophies/plaques/charms/engravings

**Section 4.** For all WAWGA tournaments, if host club states “Cart Path Only”, then the tournament is cancelled at the discretion of the tournament director and the host club. Refer to the re-schedule document in the tournament notebook as to whether a tournament may be rescheduled. In the event a tournament is cancelled, entry fees will be returned in accordance with the directions in the CTC Tournament Instructions Book, and in coordination with the host club.

## **ARTICLE VI**

### **Senior Tournament**

**Section 1.** The 18-hole and 9-hole Tournament shall be a two-day stroke play event held at Sim Park Golf Course. The field shall be limited to the first 120 entrants who are at least 50 years old.

**Section 2.** The Senior/Super Senior Tournament will be planned, conducted, and supervised by the Central Tournament Committee along with a member of the host club who will serve as a liaison between the CTC and the tournament site.

#### **Section 3. Entries**

- a. The entry fee must be submitted with the entry. If a player withdraws after the entry deadline, there will be no refund of the entry fee.
- b. Green fees and cart fees will be included in the entry fee.

#### **Section 4. Tournament Rules**

- a. Handicaps
  - 1) Each contestant's GHIN Handicap Index shall be used to determine the Course Handicap at the host club.
  - 2) An 18-hole golfer's Handicap Index shall be limited to 54.
  - 3) A 9-hole golfer's Handicap Index shall be limited to 27.
  - 4) A player may have a higher Course Handicap than the limited Handicap Index.
- b. The entrants shall be flighted within age divisions. The age divisions shall be Senior (ages 50-69) and Super Senior (ages 70+).
  - 1) Flights within each age division shall be determined by GHIN Handicap Index.
  - 2) The number of contestants within each flight shall be as consistent as possible.
  - 3) The 9-hole tournament must have at least eight (8) entrants. If there are not enough entrants, the 9-hole golfer may play in the 18-hole tournament by using her 18-hole GHIN Handicap Index.
- c. Pairings
  - 1) First day pairings shall be made by GHIN Handicap Index within each division.
  - 2) Second day pairings shall be based on the first day scores within the divisions.
- d. Play shall be two-day stroke play (gross and net).
- e. If the course is limited to carts on the cart paths only **and** red flags for the disabled are not allowed, the tournament is cancelled, but may be rescheduled.

#### **Section 5. Awards**

- a. The prizes shall be merchandise certificates.
- b. A player may win one prize within a flight.
- c. Prizes shall be awarded for overall Gross and Net winners of each age division regardless of flight and for First and Second Low Gross and First and Second Low Net in each flight.
- d. If a player wins both low gross and low net in her flight
  - 1) She shall be awarded the prize for low gross only.
  - 2) The Low Net award shall be given to the player having the next low net score in that flight.
- e. If a player wins second low gross and first low net, she shall be awarded the prize with the greater dollar value.
- f. Ties shall be broken according to the USGA Rules of Golf. **FOR OVERALL SENIOR AND SUPER SENIOR WAWGA CHAMPIONS ONLY** – If two (2) players are tied for overall champion at the



- end of the final round, a sudden death playoff will be played until there is a winner if course availability permits. If a playoff is not possible, then a scorecard playoff shall be used.
- g. In all other flights, a scorecard playoff will be used to decide the winner, per the USGA Rules of Golf (See Standing Rules – Appendix B for examples).
  - h. Special event prizes may be awarded at the discretion of the Committee. A player may win only one special event prize.
  - i. Champion Roving Trophies shall be awarded as follows:
    - 1) The Lori Payne Trophy to the 18-hole Low Gross Winner – Senior Division
    - 2) The Dean Ashmore Trophy to the 18-hole Low Net winner – Senior Division
    - 3) 18-hole Low Gross Winner – Super Senior Division
    - 4) 18-hole Low Net Winner – Super Senior Division
    - 5) The Toshi Burroughs Trophy 9-hole Low Gross Winner
    - 6) The Toshi Burroughs Trophy 9-hole Low Net Winner
    - 7) WAWGA shall pay for the engraving of all the trophies.
  - j. Tournament days shortened
    - 1) One day: Prizes shall be awarded for one day's play.
    - 2) Two days: The tournament shall be cancelled. Prizes shall be awarded by blind draw.

**ARTICLE VII**  
**Invitational Tournaments**

**Section 1.** Invitational Tournaments shall be one-day events held at the clubs specified in the Long-Range Tournament Schedule (Appendix A). The event may be one or two person events, with the format to be determined by the Central Tournament Committee (CTC).

**Section 2.** The CTC general duties for the 18-hole and 9-hole Spring and Fall Invitationals are listed in **Article V. Tournaments – General. Section 2.**

**Section 3. Entry Fee**

- a. The entry fee shall include:
  - 1) Luncheon
  - 2) Golf prizes
  - 3) One door prize (Optional)
  - 4) Cart fee (optional, but encouraged)
  - 5) Golf green fee
    - a) If the tournament is at a course not managed by Wichita Golf, the course manager or golf Pro will determine the green fees and cart fees and if members of that course should pay such fees.
    - b) If the tournament is at a course managed by Wichita Golf, the fees will be dictated by the contract between Wichita Golf and WAWGA. Wichita Golf memberships are not applicable for tournaments.
- b. Eligible players shall pay the entry fee in advance to the CTC.

**Section 4. GHIN Handicap Index**

- a. Each contestant's GHIN Handicap Index shall be used to determine her handicap at the host course.
- b. The Course Handicap of an 18-hole player shall not exceed 54.
- c. The Course Handicap of a 9-hole player shall not exceed 27.
- d. A player with a higher Course Handicap than allowed in the 18-hole or 9-hole Tournament may play in the tournament, but her Handicap Index shall be the maximum Handicap Index.

**Section 5. Flights**

- a. Players shall be placed in numerical order according to their GHIN Handicap Index. When two or more players have the same GHIN Handicap Index, positions shall be determined using the average of the differential for the last 5 scores posted and used (with asterisk) to compute the current GHIN Index. If there is still a tie, then a blind draw shall determine the positions. NOTE: Players' GHIN Handicap information can be found at [www.GHIN.com](http://www.GHIN.com).
- b. Flights shall be composed of not more than eight (8) players and not less than six (6) players.

**Section 6.** Prizes will be determined by the CTC.

## **ARTICLE VIII**

### **Wichita Match Play Tournament**

**Section 1.** An 18-hole Wichita Match Play Tournament shall be held each year. The course on which the Tournament is to be played shall be determined by the Tournament Long-Range Schedule (Appendix A). Additional non-WAWGA courses may be interspersed into the Tournament Long-Range schedule every two to three years depending on their availability at the discretion of the Central Tournament Committee (CTC). The winner shall be designated the “Women’s Match Play Champion”.

**Section 2. Eligibility (See Article II. Eligibility, Section 1. General and Section 2. Junior Golfers).**

Women who have a current GHIN Handicap, who either reside in the state of Kansas or belong to a WAWGA affiliated Member-Club or are Single members of WAWGA shall be eligible to play in the Wichita Match Play Tournament. Entry forms will be sent out approximately six (6) weeks before the tournament, with the entry open date one (1) week prior for WAWGA members to all other entrants. The Central Links Golf (CLG) staff have agreed to assist with the effort to make this tournament attractive to statewide golfers by including information in the Central Links Newsletter.

**Section 3. Fees**

- a. All eligible golfers who compete shall pay an entry fee that covers an individual participation fee, prizes, food, and other tournament expenses.
- b. The tournament expenses shall include an optional gratuity for the golf professionals of the host club, depending on tournament finances and services rendered.
- c. The entry fee shall be determined by the host club and CTC.

**Section 4.** The Wichita Match Play Tournament Chairperson is designated by the CTC.

**Section 5. Wichita Match Play Tournament Chairperson duties:**

- a. Meet with the host club pro and review Match Play Tournament guidelines.
- b. Confirm dates for the Wichita Match Play Tournament with the host Head Golf Professional at the host golf club.
- c. Coordinate with host club for reduced green/cart fees for the tournament, and dates and fees for players to play a practice round.
- d. Contact a hotel near the playing site and negotiate a “tournament price” on rooms for any out-of-town players.
- e. Review entries and confirm eligibility, confirm each mail in entry with a confirmation email. The online entries create their own receipt.
- f. Obtain the GHIN Handicap Index for each contestant.
- g. Establish competitor flights and post the list of competitors and match times prior to the start of the competition.
- h. Purchase prizes and/or prepare gift certificates.
- i. Present awards at the conclusion of the tournament.

**Section 6. Tournament Rules:**

- a. The Tournament shall be a minimum of three (3) days of Match Play format. In the event of a low turn-out, the tournament format may be changed only with a majority vote, via email, phone or a

called meeting, by the Elected and Appointed Officers of the current year of WAWGA based upon the recommendations of the CTC.

- b. Play shall be in twosomes, by tee times.
- c. Special events and proximity prizes maybe awarded based on the first day of play of the tournament, using only the first 10 holes of the designated course since not all matches continue through all 18 holes.
- d. Championship Flight players will play from a longer yardage than the rest of the flights. Yardages will be decided by the CTC and the host course professional staff.
- e. Flights
  - 1) The Tournament Champion will come from the Championship Flight
  - 2) Seed all flights EXCEPT the Championship Flight by Handicap Index in brackets of eight (8).
  - 3) If determined by the CTC, a qualifying round shall be held prior to the tournament.
  - 4) Championship Flight only: players will be seeded by their score in an 18-hole stroke play qualifying round (date to be determined by the CTC).
    - a) Any entrant with a Handicap Index of 9.9 or lower MUST play in the qualifying round.
    - b) Any entrant with a handicap higher than 9.9 may request to play in the qualifying round to try to compete for the Championship Flight.
    - c) The bracket size for the Championship Flight will be either 8 or 16 depending on the number of entrants. If there are less than twelve (12) entrants, an 8-golfer bucket will be used. If there are twelve (12) or more entrants, a bracket of 16 golfers will be used. Byes may be used to complete the brackets as needed.
    - d) The final decision on the bracket size will be determined by the CTC after entries are received, and the number of qualifiers have been determined.
    - e) Participants who played in the qualifying round and did not qualify will be placed in the next flight according to her Handicap Index.
  - 5) Seeding within flights shall be determined by GHIN Handicap Index. When two or more players have the same GHIN Handicap Index, seeding shall be determined using the average of the differential for the last five (5) scores posted and used (with asterisk) to compute the current GHIN index. If there is still a tie, then a blind draw shall determine the positions. NOTE: Players GHIN Handicap Index information can be found at [www.GHIN.com](http://www.GHIN.com).
  - 6) If the highest-numbered flight contains between four (4) and eight (8) players, the flight shall be completed with Byes.
  - 7) The draw for match play shall be according to the General Numerical Draw. (USGA Rules of Golf, Committee Procedures). (See Standing Rules Appendix C-1.)
  - 8) Each flight will have a Consolation Flight consisting of those players who lose their match on the first day of the tournament.
  - 9) A player must play and lose her first match to be eligible to play in a Consolation Flight. A Bye in the first round means that the player won her first match and is not eligible for the Consolation Flight.
  - 10) Match times for the first day of play shall be based on the player with the lowest seed (#1 is the lowest seed); the lowest seed plays at the earliest match time. On the second day of play, the order of play begins with Championship Flight (low seeds first), followed by the Championship Consolation Flight (low seeds first), followed by the remaining flights in order (Championship then Consolation in each flight). On the final day of play, the order is reversed. (See Appendix C-2).
- f. A player more than five (5) minutes late for her starting time shall be disqualified. Her opponent shall win by default. (USGA Rules of Golf Rule 5.3).
- g. Rules of Arbitrations:

- 1) The Rules Committee established by the CTC shall arbitrate all questions that arise concerning the rules of play, in accordance with the USGA Rules of Golf.
- 2) The administration of the rules shall be under the supervision of the Golf Pro at the host club.

**Section 7. Awards**

- a. The following awards shall be selected and presented by the CTC:
  - 1) The winner and runner-up in all flights.
  - 2) Special events winners.
  - 3) Door prizes (optional).
  - 4) Awards shall be purchased in descending order from A (most expensive) to E (least expensive) and be distributed by the following formula:

Champion	A Award
Champion Runner-Up	B Award
Flight Winners	B Award
Flight Runner-Up	C Award
Consolation Flight Winner	C Award
Consolation Runner-Up	D Award
Special Event	E Award

## **ARTICLE IX**

### **Pro-Am Tournament**

#### **Section 1**

- a. The Pro-Am Tournament may be played on another course and held as a separate event from the Wichita Match Play Tournament based upon the discretion of the Central Tournament Committee and the availability of the host course. In the event the Pro-Am is not held as part of the Wichita Match Play Tournament, a practice round would be provided all entrants of the Wichita Match Play Tournament.
- b. The number of teams entered in the Tournament shall be unlimited provided the host club is able to accommodate the size based upon number of golf carts, etc. The CTC will determine the number of entrants in conjunction with the host club.
- c. Each team shall be composed of one (1) Pro and two (2) to four (4) women amateurs.
  - 1) The Pro member of the team shall be either the Club Pro, Assistant Pro, local unattached Pro, or a local Amateur. The Pro member shall not receive handicap strokes.
  - 2) The women amateurs shall be 18-hole and/or 9-hole members of the same club.
- d. The Member-Club 18-hole Team Play Captain shall coordinate the make-up of all teams from her club. If a Member-Club does not have an 18-hole Team Play Captain, the 9-hole Team Play Captain shall coordinate the make-up of teams from her club.
- e. The Tournament format shall be decided by the Central Tournament Committee.
- f. The entry fee shall be determined by the CTC in coordination with the host club and covers the entire team, including the Pro.
- g. Amateurs playing in the Pro-Am shall:
  - 1) Pay the Pro-Am team entry fee.
  - 2) Pay the green fee/cart fee as negotiated by the CTC and the host club.
  - 3) Play with a USGA Handicap Index limited to 36.
- h. Prizes
  - 1) There shall be a minimum of one prize for each five teams entered.
  - 2) In the event two or more teams tie for first place, the percentages allocated for first, second, or more places shall be added, divided equally, and awarded to each team. Other tied positions shall use the same procedure.
  - 3) The Golf Pros shall receive money for awards.
  - 4) The men and women amateurs shall receive merchandise certificates from the Pro Shop of the host club.
- i. Golf Professionals shall be eligible to compete in an optional competition.
  - 1) The Host Club Pro shall set the entry fee for the optional competition.
  - 2) The prize money shall be distributed at the discretion of the Host Club Pro based on a fair ration of the number of entrants in the event.

## ARTICLE X

### Four-Ball Tournament

**Section 1.** The Four-Ball Tournament shall be a two (2) day, 36-hole event rotated among all golf courses in WAWGA specified in the Long-Range Tournament Schedule (Appendix B).

**Section 2.** The CTC will conduct the tournament. Refer to **Article V. Tournaments – General, Section 2.**

**Section 3.** The Four-Ball Tournament shall be a two-woman, low ball event.

**Section 4.** The eligible (See **Article II. Eligibility**) partners may be from different Member-Clubs or may combine with Single WAWGA members. Women who have a current GHIN handicap and who reside in the state of Kansas, but DO NOT belong to WAWGA shall also be eligible to play in the WAWGA Four-Ball Tournament for an extra \$5.00 fee. A 9-hole golfer may play in this tournament by using her 18-hole GHIN Handicap Index.

**Section 5.** Play shall be two (2) day total Low Ball for low gross and low net in each flight.

**Section 6.** Play shall not be rescheduled in play if cancelled due to inclement weather or the course is declared unplayable. Any course requiring “cart path only” shall be deemed unplayable and the tournament will be cancelled at the determination of the CTC Director and the host club Pro.

**Section 7.** Green fees shall be included in the entry fee.

**Section 8. Flighting:** The CTC shall make up the flights after all entries have been received. The flights shall be as equal in number of teams as possible with a minimum of five (5) teams per flight.

**Section 9. Flight Procedure:**

- a. The person with the lowest GHIN Handicap Index (A player) shall be used to determine the flight and position of the two-person team.
- b. When two (2) or more A players have the same GHIN Handicap Index, positions shall be determined using the average of the differential for the last five (5) scores posted and used (with asterisk) to compute the A players’ current GHIN Index. If there is still a tie, the B players GHIN Handicap Index shall be used to determine the team position. If the B players also have the same GHIN Handicap Index, positions shall be determined using the average of the last five (5) scores posted and used (with asterisk) to compute the B players current GHIN Index. If there is still a tie, a blind draw shall determine the positions. NOTE: Players’ GHIN Handicap information can be found at [www.GHIN.com](http://www.GHIN.com).
- c. When the dividing line for flights contains two (2) or more teams with tied GHIN Handicap Indexes, the procedure found in **Section 9. Flighting Procedure, a and b**, shall be used to determine within which flight the team shall compete.

**Section 10. Course Handicap Limits:**

- a. Each contestant’s GHIN Handicap Index shall be used to determine her handicap at each course. The Course Handicap may be different at the two courses due to the Slope Rating of the host clubs.

- b. For all flights: The difference in partner handicaps shall be no more than 10 strokes based off the lowest handicap player's index. *Example: Last place team Handicap Indexes: Player A = 17.1, Player B = 19.5. No player in Flight A shall play with a Handicap Index any higher than 17.1.*
- c. GHIN Handicap Index limit for 18-hole golfers is now 54 and 27 for 9-hole players.

#### **Section 11. Player's Partner Cannot Play**

- a. If after the entry deadline, a player cannot play, the partner may get a substitute before flights are determined.
- b. If during the tournament a player's partner cannot play, the player may play alone.

#### **Section 12. Prizes**

- a. Prizes will be determined by the CTC.
- b. The percentage of the prize portion of the entry fees, which each winning team shall receive, shall be determined by the CTC. Gross and Net awards shall be equal in value by flight.
- c. In the event two or more teams tie for first place, the award percentages allocated for the tied positions shall be added together and equally divided. Other tied positions shall use the same procedure.
- d. The prizes shall be merchandise certificates from the host club Pro Shop.
- e. A team may not win both gross and net competition.
  - 1) The team shall be awarded the highest value prize that it earned. (*Example: 2<sup>nd</sup> place Low Net would be a higher value than 3<sup>rd</sup> place Low Gross*).
  - 2) If a team wins the same prize in both Low Gross and Low Net, the team shall win the Low Gross prize.



**ARTICLE XI**  
**ORLANDO TOURNAMENT**

**Section 1.** The Orlando Tournament shall be an 18-hole Scotch Foursome with preferred tee shots and held at the club specified in the Long-Range Tournament Schedule (Appendix A).

**Section 2.** The CTC shall conduct the tournament. Refer to **Article V. Tournaments – General, Section 2.**

**Section 3.** Each Member-Club may have two (2) teams.

- a. The two teams from each Member-Club shall not be paired together.
- b. The two teams shall consist of:
  - 1) The Head Golf Pro and the current Member-Club 18-hole Champion.
  - 2) The Assistant Golf Pro and the current Member-Club 18-hole Runner-up.
- d. Substitutes may be made from participants in the Member-Club 18-hole Championship Tournament.
- e. Substitutions may be made by the Head Golf Pro for the pro positions.
- f. Pairings may be made by the CTC or the Pro at the Host club either by handicap of the amateur players, or by blind draw.

**Section 4.** The entry fee shall include:

- a. Prize money
- b. Green fee (see **Article V – Tournament, Section 2 -- General**).

**Section 5.** The entry fee, less expenses, shall be divided 50% (1<sup>st</sup>), 30% (2<sup>nd</sup>), 20% (3<sup>rd</sup>) for both the golf pros and the women amateurs.

- a. The Pros shall receive money and the amateurs shall receive merchandise gift certificates from the host club Pro-Shop.
- b. In the case of ties, the money allocated for the tied positions shall be added together and equally divided.

## ARTICLE XII

### Team Play – 18-Hole

**Section 1.** The Member-Club Team Play Captains shall hold a regular meeting in March.

- a. A special meeting of the Member-Club Team Play Captains may be called by the City Team Play Captain and shall be called upon the written request of two (2) Member-Club Team Play Captains. The purpose of the meeting shall be stated in the call. Except in cases of emergency, at least fourteen (14) days of notice shall be given.
- b. Two-thirds of the Member-Club Team Play Captains shall constitute a quorum.

**Section 2. Membership:** Each Member-Club of WAWGA may enter city Team Play competition with one (1) team of six (6). The intent of each Member-Club must be communicated to the City Team Play Captain no later than January 1. Intent must be indicated on the WAWGA's Secretary's annual information form.

**Section 3. 18-hole City Team Play Captain shall:**

- a. Schedule and preside over the Member-Club Team Play Captains regular or called meeting.
- b. Enforce the Team Play Standing Rules.
- c. Make and publish the Team Play schedule.
- d. Indicate on the Team Play schedule the effective revision date (GHIN) to use for each team play match.
- e. Keep a record of the points won by each team.
- f. Email weekly to each Member-Club Team Play Captain the current point standings and number of matches played by each team after each round.
- g. Email a final report at completion of the season to the Member-Club Team Play Captains.
- h. Purchase awards for the first and second place winners in each division and present the bill to the WAWGA Treasurer. These shall be awarded at the Fall WAWGA Meeting.

**Section 4. Eligibility:**

- a. See **Article II. Eligibility, Section 1 – General; Section 2 – Junior Golfers.**
- b. 18-hole Play: Only players who regularly play in the 18-hole division of a Member-Club shall be eligible. When a Member-Club does not have an adequate number of 18-hole players available, 9-hole players from the Member-Club may play.
- c. A player who belongs to two (2) Member-Clubs may play 18-hole Team Play for one (1) club and 9-hole Team Play for the other as long as she does not switch between the two (2). Per 9-hole Team Play Standing Rules, only 9-hole players of a Member-Club are eligible for team play.
- d. A player must post at least three (3) scores within the preceding thirty (30) days to be eligible. For May play, this rule shall be waived.

**Section 5. Each team member shall:**

- a. Pay for Team Play fee to her team captain or directly to the club depending on the wishes of the club pro. At clubs managed by Wichita Golf, Wichita Golf memberships apply.
- b. Rent ½ a golf cart. She does not have to ride.

**Section 6. Member-Club 18-hole Team Play Captain's duties shall be:**

- a. Furnish the City Team Play Captain a list of eligible team players by a date determined by the City Team Play Captain. The list will be in alphabetical order and include each individuals' GHIN

number. The first of each month she shall notify the City Team Play Captain by phone, mail, or email of any changes in the list of eligible players (see **Section 4. Eligibility**). If a player becomes eligible after the first of the month, the Team Play Captain may phone or email her name and GHIN number to the City Team Play Captain.

- b. Select players for Team Play:
  - 1) Eligible (See **Section 4. Eligibility**) players shall be selected from the Handicap Indexes published on the effective revision date (GHIN) as indicated on the Team Play schedule.
  - 2) In the event an emergency occurs, a substitute may be made following the lineup procedure. The City Team Play Captain must be notified as soon as possible.
- c. The Visiting Team Play Captain shall phone or email her lineup of players and their Handicap Indexes no later than the Wednesday prior to day of play to the Host Team Play Captain.
- d. The Host Team Play Captain shall convert the visiting team's Handicap Indexes to the host Course Handicap using the conversion chart and email her lineup of players and pairings to the Visiting Team Play Captain by 12:00 p.m. the day preceding the match.
- e. Check the eligibility of each person on each team.
- f. The Team Play Captain shall fill out the scorecards before Team Play.
- g. Be responsible for her players' familiarity with USGA Rules, recap of some USGA Rules regarding match play, and WAWGA Team Play Etiquette.
- h. The Visiting Team Play Captain shall collect the Team Play fee and pay this amount to the host golf course or be sure individual players pay directly to the host course depending on the wishes of the club pro.
- i. Decide, with the opposing Member-Club Team Play Captain, whether play should be postponed due to inclement weather which may include if the course is cart path only. If either captain wants to reschedule if it is cart path only that is allowed. If both captains agree to play when it is cart path only that is fine. Any course that is cart path only can be deemed unplayable by either captain.
- j. Reschedule, with the host Member-Club Team Play Captain, any postponed regular Team Play.
- k. All rescheduled team play matches must be completed by October 15.
- l. The Host Team Play Captain shall notify the City Team Play Captain of the results.

## **Section 7. Lineup of Players**

- a. The players shall be placed in order starting with the lowest Handicap Index and will play in that order. Failure to invite any eligible team member or pairing players based upon anything other than handicap is prohibited.
- b. In the event of a tie, the player with the lower Handicap Differential will be placed first in the line-up. In the event of a tie of Handicap Differential, the player with the lower Handicap Differential from the preceding Team Play shall have priority.
  - 1) 18-hole Team Play: In the event of there are not enough 18-hole players to field a team, 9-hole players may complete the team.
  - 2) 9-hole players shall be placed in the lineup where their Handicap Indexes fall in the order of players.
- c. If a player is not available when it is her tee time:
  - 1) The Team Play Captain has the discretion of moving players up in position.
  - 2) An individual player may compete alone.
- d. If a player has stated that she shall be there, but is detained for any reason, her partner shall compete alone against the opposing twosome.
  - 1) The late player shall join her partner on a future hole (not during the play of a hole).
  - 2) If a player is called off the course or becomes ill, her partner shall play alone. The player who dropped out may rejoin the match on a future hole but not during the play of a hole.

## Section 8. Team Play Format

- a. Team Play shall be Low Ball Gross and Net Match Play with handicap limited to a course handicap of 32.
- b. Each Member-Club shall field a team with three (3) sides (A, B, C) for a total of six (6) players.
- c. Day of Play:
  - 1) Team play shall be played as scheduled by the City Team Play Captain using Friday as the preferred day of play.
  - 2) Matches will be played from the tees which a Member-Club's ladies play their regular competitions.
  - 3) In the event of a postponement of play due to inclement weather or the course being deemed unplayable, the match shall be rescheduled with mutual agreement between the teams on any day of the week.
  - 4) If a match has to be stopped and is incomplete due to weather the following procedures shall apply after a 45-minute delay.
    - a) If up to six (6) holes have been played, get rain checks and reschedule with mutual agreement between teams on any day of the week.
    - b) If up to 9 to 14 holes have been completed, points won or lost on the first 9 holes will be officially recorded for team play. The Team Play Captain shall work with her club pro on the cost and rescheduling for the un-played holes and mutually agree with the guest Team Play Captain on the play date for the last 9 holes.
    - c) If 15 holes or more have been completed, the match shall be considered complete, and points won/lost officially recorded.
    - d) New team lineups may be formed for the rescheduled match. The handicap revision date for the day of the make-up match shall be used.
- d. Unplayable courses: Any course closed to riding carts shall be deemed unplayable and Team Play will be cancelled for the day. Any course that carts are limited to cart path only the Team Play Captains may agree to go ahead and play as scheduled. However, if one Team Play Captain elects not to play, then Team Play will be cancelled for the day and rescheduled.
- e. Time of Play:
  - 1) Play shall begin at 9:00 a.m. the months of May, September, and October.
  - 2) Play shall begin at 8:00 a.m. the months of June, July, and August.
  - 3) An alternate time may be designed if agreed upon by the two Member-Club Team Play Captains.
- f. Scoring:
  - 1) Two (2) points shall be awarded per hole. One (1) point for gross and one (1) point for net. If a hole is halved each team shall receive a half (1/2) point.
  - 2) Each team shall report the results of the match to their Member-Club Team Play Captains.
- g. Forfeiture of Points:
  - 1) A team playing an ineligible player shall forfeit all points won for the match with the ineligible player, i.e., an ineligible player in first position would lose only the points for her team of two (2).
  - 2) If a team is short players, any forfeiture shall come at the bottom of the team line-up.
  - 3) Any match that is forfeited will be scored as follows:
    - i. The team that forfeits will receive zero (0) points.
    - ii. The team that was forfeited upon will receive 11 points for each Gross and Net match.
    - iii. If the entire team forfeits, the other team would receive 66 points – 33 points for Gross and 33 points for Net.
    - iv. If one match is forfeited, the other team would receive 11 points for Gross and 11 points for Net.

- h. Posting of Team Play scores: Team Play scores may be posted according to the USGA Handicap System.
  - 1) If a player starts but does not complete a hole or is conceded a stroke, that player shall record for handicap purposes the score she *most likely would have made*.
  - 2) The most likely score consists of the number of strokes already taken plus, in the player's best judgement, the number of strokes that the player would need to complete the hole from that position more than half the time. This number may not exceed the player's Net Double Bogey limit.

#### **Section 10. Awards**

- a. First and Second place awards for the gross and net competition shall be presented at the Fall WAWGA meeting.
- b. In the event of a tie for First and Second place, each of the tied teams shall receive an award.

### **9-Hole**

#### **Section 1.** The Member-Club Team Play Captains shall hold a regular meeting in March.

- a. A special meeting of the Member-Club Team Play Captains may be called by the City Team Captain and shall be called upon the written request of two (2) Member-Club Team Play Captains. The purpose of the meeting shall be stated in the call. Except in cases of emergency, at least notice of fourteen (14) days shall be given.
- b. Two-thirds of the Member-Club Team Play Captains shall constitute a quorum.

#### **Section 2. Membership:** Each Member-Club of WAWGA may enter city Team Play competition with one or two teams. The intent of each Member-Club must be communicated to the City Team Play Captain no later than January 1. Intent must be indicated on the WAWGA's Secretary annual information form.

#### **Section 3. 9-hole City Team Play Captain shall:**

- a. Schedule and preside over the Member-Club Team Play Captains regular or called meeting.
- b. Enforce the Team Play Standing Rules.
- c. Make and publish the Team Play schedule.
- d. Indicate on the Team Play schedule the effective revision date (GHIN) to be used for each team play match.
- e. Keep a record of the points won by each team.
- f. Email monthly to each Member-Club Team Play Captain the current point standings and number of matches played by each team.
- g. Email a final report at completion of the season to the Member-Club Team Play Captains.
- h. Purchase awards for the First and Second place winners in each division and present the bill to the WAWGA Treasurer. These shall be awarded at the City Fall Invitational or the City Fall WAWGA meeting.

#### **Section 4. Eligibility:**

- a. See **Article II, Eligibility, Section 1 – General and Section 2 – Junior Golfers**
- b. 9-hole Play: only 9-hole players of a Member-Club shall be eligible.

- c. A player must post at least three (3) scores within the preceding thirty (30) days to be eligible. For April and May play, this rule shall be waived.

**Section 5. Each team member shall:**

- a. Pay the appropriate Team Play fee to her Team Play Captain. At clubs managed by Wichita Golf, Wichita Golf memberships apply.
- b. Rent ½ a golf cart. She does not have to ride.

**Section 6. Member-Club 9-hole Team Play Captain's duties shall be:**

- a. Furnish the City Team Play Captain a list of eligible team players by a date determined by the City Team Play Captain. The list will be in alphabetical order and include each individual's GHIN number. The first of each month she shall notify the City Team Play Captain by phone, mail, or email of any changes in the list of eligible players (see **Article II. Eligibility**). If a player becomes eligible after the first of the month, the Team Play Captain may phone or email her name and GHIN number to the City Team Play Captain.
- b. Select players for Team Play:
  - 1) Eligible (See **Article II. Eligibility, Section 1 – General, Section 2 – Junior Golfers**) players shall be selected from the Handicap Indexes published on the effective revision date (GHIN) as indicated on the Team Play schedule.
  - 2) In the event an emergency occurs, a substitute may be made following the lineup procedure. The City 9-hole Team Play Captain must be notified as soon as possible.
- c. The Team Play Captains shall phone or email to each other their lineup of players and their Handicap Indexes no later than 12:00 p.m. prior to day of play.
- d. The host Team Play Captain shall convert the visiting team's Handicap Indexes to the host Course Handicap using the conversion chart.
- e. Check the eligibility of each person on each team.
- f. The host Team Captain shall fill out the scorecards before Team Play.
- g. Be responsible for her player's familiarity with USGA Rules, recap of some USGA rules regarding Match Play, and WAWGA Team Play Etiquette.
- h. The visiting Team Play Captain shall collect the Team Play fee as set by the contract between Wichita Golf and WAWGA and pay this amount to the host golf course.
- i. Decide, with the opposing Member-Club Team Play Captain, whether play should be postponed due to inclement weather.
- j. Reschedule, with the opposing Member-Club Team Play Captain, any postponed regular Team Play. Notify the City 9-hole Team Play Captain of the rescheduled date and time and the reason for rescheduling.
- k. The host Team Play Captain shall notify the City 9-hole Team Play Captain of the results.

**Section 7. Lineup of Players**

- a. The players shall be placed in order starting with the lowest Handicap Index. In the event of a tie, the player with the lower Handicap Differential will be placed first in the line-up. In the event of a time of Handicap Different, the player with the lower Handicap Differential from the preceding Team Play shall have priority.
- b. 9-hole players shall be placed in the lineup where their Handicap Indexes fall in the order of players.
- c. If a player is not available when it is her tee time:
  - 1) The team play captain has the discretion of moving players up in position.
  - 2) An individual player may compete alone.
- d. If a player has stated that she shall be there, but is detained for any reason, her partner shall compete alone against the opposing twosome.

- 1) The late player shall join her partner on a future hole but not during the play of a hole.
- 2) If a player is called off the course or becomes ill, her partner shall play alone. The player who dropped out may rejoin the match on a future hole but not during the play of a hole.

### **Section 8. Team Play Format**

- a. Team Play shall be Low Ball Gross and Net Match Play with handicap limited to a course handicap of sixteen (16).
- b. Each Member-Club may field two (2) 9-hole teams (A and B). The team shall be composed of one (1) twosome.
- c. When the host club has declared only one team for the season, the second team will NOT be allowed playing privileges at the host course.
- d. Day of Play:
  - 1) Team Play matches shall be played as scheduled by the City 9-hole Team Play Captain using Friday as the preferred day of play.
  - 2) Matches will be played from the tees which a Member-Club's ladies play their regular competitions.
  - 3) In the event of a postponement of play due to inclement weather or the course being deemed unplayable, the match shall be rescheduled with mutual agreement between the teams.
  - 4) New team lineups may be formed for the rescheduled match. The handicap revision date for the day of the make-up match shall be used.
- e. Unplayable Courses: Any course closed to pull carts shall be deemed unplayable.
- f. Time of Play:
  - 1) 9-hole teams shall play their matches in accordance with their team play schedule.
- g. Scoring:
  - 1) 9-hole teams shall play for two (2) points per hole. One (1) point for Gross and one (1) point for Net.
  - 2) Each team shall report the results of the match to the Member-Club Team Captains.
- h. Forfeiture of Points:
  - 1) A team playing an ineligible player shall forfeit all points won for the match with the ineligible player, i.e., an ineligible player in the first position would lose only the points for her team of two (2).
  - 2) If a team is short players, any forfeiture shall come at the bottom of the team lineup.
- i. Posting of Team Play Scores
  - 1) Team Play scores may be posted according to the USGA Handicap System.
  - 2) If a player starts but does not compete a hole or is conceded a stroke, that play shall record for handicap purposes the score she *most likely would have made*.
  - 3) The most likely score consists of the number of strokes already taken plus, in the player's best judgment, the number of strokes that the player would need to complete the hole from the position more than half the time. This number may not exceed the player's Net Double Bogey limit.

### **Section 9. Awards**

- a. First and Second place awards for the Gross and Net competitions shall be presented at the City Fall WAWGA meeting.
- b. In the event of a tie for First or Second place, each of the tied teams shall receive an award.

**ARTICLE XIII**  
**Junior Girls City Championship**

**Section 1.** The 18-hole and 9-hole tournament shall be a two-day stroke play event held each year during the month of July at Sim Golf Course.

**Section 2. Eligibility**

- a. Entrants should be between the ages of 10 and 18 and be a resident of Kansas. Entrants may choose to enter the 18-hole Division or 9-hole Division regardless of age. Once tournament play begins, changing Divisions will not be permitted.
- b. The Junior Girls City Championship is an event not tied into eligibility requirements of the Wichita Match Play Tournament and Team Play.

**Section 3. Chairperson shall:**

- a. Be the Junior Girls Coordinator, an appointed member of the WAWGA Board of Directors and serve a minimum of two (2) years.
- b. Determine entry fee and responsibilities of committee as necessary.
- c. Contact the media to report tournament results.
- d. Submit a report to the WAWGA Board of Directors to include tournament results and finances related to the tournament.
- e. Serve as liaison with area golf coaches.
- f. Conduct tournament correspondence with/to:
  - 1) Area high school coaches for names of current and future candidates.
  - 2) Club pros
  - 3) All area golf clubs.
  - 4) Various media outlets including social media with the prospective participants.

**Section 4. Entries**

- a. The entry fee must be submitted with entry. If a player withdraws after the entry deadline, there shall be no refund.
- b. Green fees are included in the entry fee.

**Section 5. Tournament Rules**

- a. Each participant's GHIN Handicap Index shall be used to determine pairings. If Index is not available, the participant's average score shall be used instead.
- b. Pairings
  - 1) First day pairings shall be made by GHIN Handicap Index or average score.
  - 2) Second day pairings shall be based on the first day scores.
  - 3) Play shall be two-day scratch stroke play competition.
- c. Additional Tournament Guidelines
  - 1) Participants must walk and are not eligible to take a golf cart. Push/pull carts are allowed.
  - 2) USGA Rules will be in effect with the exception listed on the rules sheet given prior to the start of the tournament, and those noted in the **WAWGA Standing Rules, Article IV, Section 1.**
- d. Ties
  - 1) In the event of a tie for the Overall Champion, a sudden-death playoff will begin immediately following the end of the stipulated round, beginning on hole 1.



- 2) Ties within an age group will be determined by matching scorecards as referenced in the USGA Decisions on the Rules of Golf, Appendix 1, Part B, 10 (c).

**Section 6. Awards**

- a. Prizes shall be 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place trophies or plaques awarded in the following age divisions: 10-12 years; 13-14 years; 15-16 years and 17-18 years.
- b. There will be an Overall Tournament Champion determined by low gross score of two days. The Girls City Junior Champion will come from the 18-hole Division. The Champion will have her name engraved on the roving trophy which will be displayed for the following year at the golfing club where she is a member or course where she plays golf. In addition, she will receive a trophy or plaque that states she is the Overall Champion.

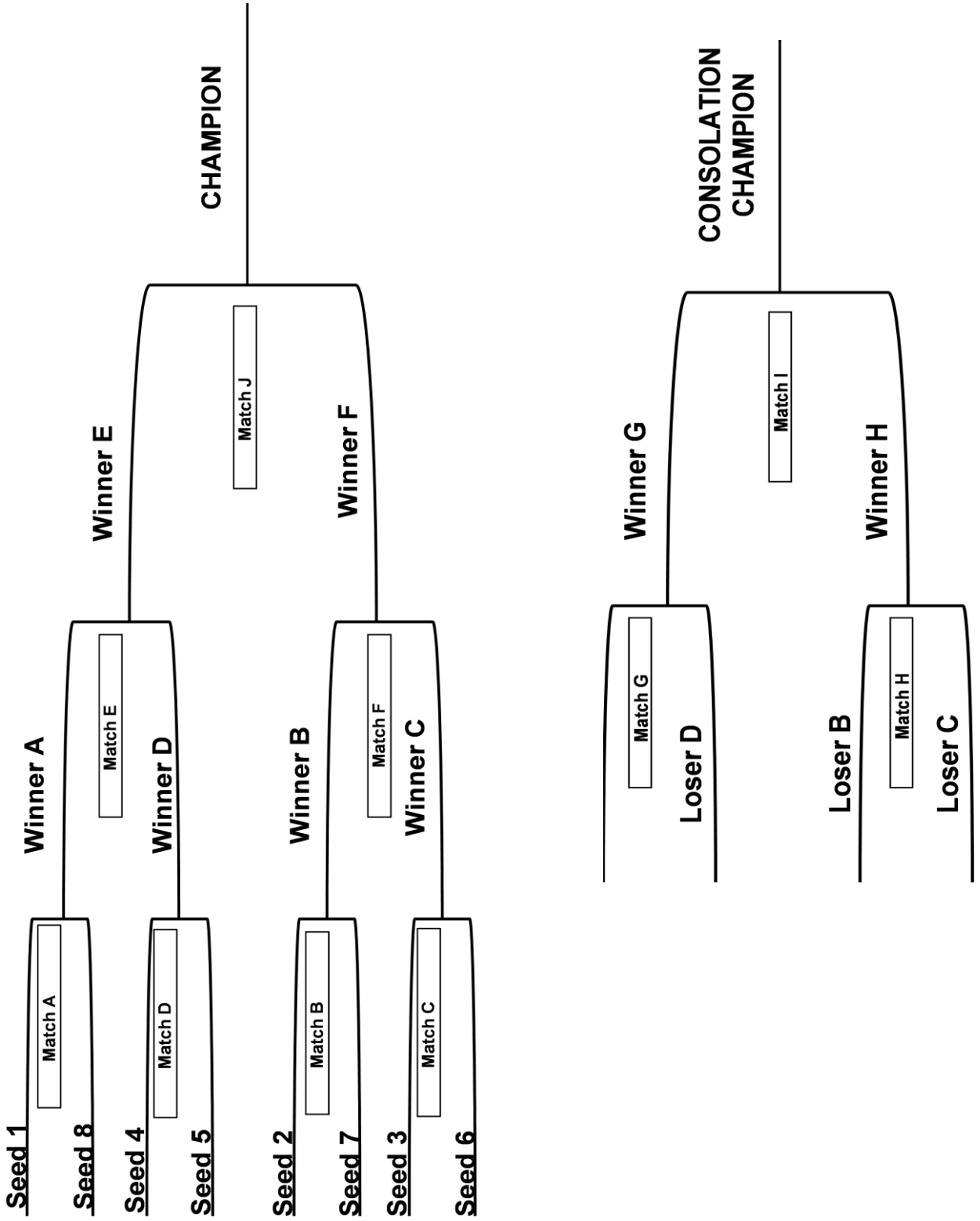

**Tie breaking procedure:** Ties for first and second place, gross and net, in each flight shall be broken using the last 9 holes of the second round, if necessary, the last 6 holes, then the last 3 holes and if necessary the 18<sup>th</sup> hole. The Low Net playoff shall allot handicap strokes on the scorecard, so that net scores are used.

**Scenario 1** – Players A and B have tied for first place gross. Using the procedure above, Player A and B have tied for the last 9 holes at 43 per player. Therefore, the next step is to look at the last 6 holes. Player A has a total of 29 (3+5+4+6+7). Player B has a total of 29 (3+5+3+5+6+7). Both tie. The next step would be to use the last 3 holes. Player A has a total of 17 (4+6+7). Player B has a total of 18 (5+6+7). Player A wins first place gross while Player B wins second place gross as long as she is not eligible for any other flight prize.

**Scenario 2** – Players C and D have tied for first place net. Using the procedures above, on the last 9 holes played, Player C has a net score of 33 (42 – 9). (Player C has 10 pops on the front side and 9 pops on the back side). Player D has a net score of 33 (43 – 10). (Player D has 11 pops on the front and 10 pops the back) Therefore the next step is to look at the last 6 holes. Player C has a net score of 23 [(3+5+4+4+6+7) – 6 pops]. Player D has a net score of 22 [(3+5+3+5+6+7) – 7 pops {2 pops on Hole #18 + a pop on each of the other 5 holes}]. Player D would win first place net while Player C would receive second place net, as long as she is not eligible for any other flight prizes.
