### REPORTS

1. President (Nancy Knopp) requested volunteers to review the 2025 WAWGA account books in January 2026. Carol Keller, Carol Shelton and Denise Denning will be on the Review Committee.
2. Secretary (Alice Kaul) - Motion to approve the 2025 Spring Board of Directors Meeting Minutes was seconded and passed unanimously. Reminded clubs that their Officer Rosters due by December 1st if possible to support the CTC pre-season planning.
3. Treasurer (Cheryl Greiving) - The Financial Report was distributed electronically to Club Presidents. After discussion of the 2026 proposed budget, it was moved and seconded to accept the financial report and 2026 proposed budget (2 separate motions). Both the financial report and budget motions were seconded, and passed unanimously.

4. Tournament Director - Marla Lindenmeyer
  - a. Reminded clubs to not schedule club events on the same day as WAWGA events.
  - b. Explained proposed changes to the following Standing Rules and why required. These changes were sent electronically to club presidents two weeks before meeting for review..

PROPOSAL #1: WAWGA Invitational Tournaments (9- and 18-hole Spring and Fall Invitationals will be changed to 9- and 18- Hole Spring and Fall Open Tournaments, Rationale - Invitational suggests being invited. The “open” wording is more inclusive and inviting to members.

PROPOSAL #2: WAWGA Refund Policy.

- a. Withdrawal before the entry deadline - Refund amount is the entry fee
- b. Withdrawal following the entry deadline and up to one day in advance of the tournament - Refund is green fee and cart fee. Rationale – This would cover any expenses incurred such as prizes and/or meals.
- c. Withdrawal on the day of the tournament - No refund, except in emergency situations as determined by the CTCD.
- d. Cancellation by WAWGA due to weather-related issues will result in full refunds for players, provided WAWGA does not have to pay for any expenses incurred by the host club. In that event, costs will be divided and shared equally among players refunds.

After discussion, a motion was made to accept the 2 proposals. Motion was seconded and passed unanimously. A separate motion was made to align the Standing Rules to the proposed changes above. Motion was seconded, and passed unanimously.

5. 9-Hole Team Play Captain (Holly Anderson) - Holly announced winners of team play for 9-Hole and distributed awards:
  - a. A team: First: Willowbend; Second: Reflection Ridge.
  - b. B Team: First: Rolling Hills; Second: Auburn Hills. Awards were distributed.
